Superintendent report for October 14, 2021:

This evening I will be covering strategic initiatives: Student Achievement, Effective Instruction, and Student Connectedness.

1.0- Student Achievement:

 We have a special presentation by Antelope Valley College as potential partners this evening. Over the past several months, the AVC president, Mr. Ed Knudson and the Interim Dean of Community Projects and Extended Learning. Ms. Cathy Hart and I have been finalizing a tentative proposal for Dual Enrollment opportunities for Vasquez High School. Topic is an agenda item tonight.

Areas we explored during our planning meetings included:

- District responsibilities, AVC responsibilities
- Timeline and requirements for implementation.
- Outreach and marketing
- Possible classes to be taught by AVC professors at VHS. Examples discussed include Math 102, English 101, Music Appreciation, and Introduction to Humanities.
- o The overarching goals of dual enrollment option for our Vasquez HS students is to better position them on how to best transfer to AVC or any community college of their choice to fulfill their IGETC and gen ed. courses by taking college level courses at Vasquez HS.
- o AVC will send us the instructor/professor
- Our district's only financial obligation- purchasing of the textbooks for students
- o Possible courses discussed for Vasquez HS- Math 110 or 115; Eng. 101 (ideal for HS students), then Eng. 102- critical thinking/literature; Music Appreciation (to include history of rock n roll and hip hop); Humanities courses an example provided a Stress management course, taught by a former AVC baseball coach, highly recommended courses for older teens.

- o AVC does not charge students for taking any of their courses
- o Research indicates that HS students talking 3 college courses as part of dual enrollment is a good predictor of college success.

Again, thank you Cathy Hart for taking a part tonight in joining us for a short presentation later this evening where we will hear more about this potential collaboration as well as field questions form our board.

2.0- Effective Instruction and Leadership:

At this time, we would like to highlight our district's new partnership with the L.A. Arts Education Collective.

The LA County Arts Education Collective brings together leaders and practioners to learn, collaborate and network. The Collective partners with regional organizations to reach a range of school district stakeholders, from education foundations to arts coordinators and school board members.

Accessing this robust network will help increase visibility of our district successes. Our district's efforts will be prominently featured as part the story of arts education in LA County.

The Arts Ed Collective dedicates a staff person to supporting our district. Our first collaborative meeting was held on October 6th. The collaborative is comprised of parents, students, staff, and community partners with a passion for the arts. During the 2021-2022 academic year, the collaborative's goal is to develop an Arts Infrastructure Strategic Plan that will increase the quality, quantity, and equity of arts instruction in our schools starting in the fall 2022.

School districts in the Arts Ed Collective that have strategic plans for arts education that have been formally adopted by their local school boards are eligible to apply for funding. Matching grants offer financial support to assist school districts in achieving key action items identified in our district arts plans. More to come on this exciting collaboration.

COVID Report: Yellow needs updating

• I'd like to provide an up to date COVID report, data pulled from LACDPH. 742 news cases as reported to LACDPH for October 12th as comparted to 1,322 new cases for September 19th as reported at our last board meeting on September 23rd. The testing positivity rate a 7-day average for the week of October 5th is .93% compared to the week of September 12th which reported the rate at 1.73%.

The percentage of individuals tested with a diagnostic COVID test since the week of October 5th comes in at 142,722 as compared to September 12th which came in at 122,257.

- Within the span of these past two weeks, 9/20-10/4, as a district we had 5 students who tested positive for COVID.
 - I'd like to share a single snapshot of the number of students that were on active quarantine (due to possible exposure) on October 4th: 141 students, district-wide.
- Again, I'd like to reiterate the importance of a self-check at home prior to students arriving on campus. Please look for symptoms such as a cough, fever, and shortness of breath. If you believe your child may be

experiencing these symptoms, please contact your school site for additional guidance.
