Superintendent report for September 8, 2022:

Student Achievement, Effective Instruction and Leadership, Community Engagement, and Student Safety & Connectedness, Utilization of Fiscal Capital.

Student Achievement:

- ➤ High Desert Middle School proudly held their Back to School Night event last week, Thursday, September 1st. Parents, students, and staff started at the gym/MPR for a presentation on the teaching and learning and enrichment activities planned for this current academic calendar.
- ➤ As of yesterday our overall enrollment is 1,013.

With that said, the two sites impacted most with the increase in enrollment are Meadowlark and High Desert School.

Originally, we were looking to add 1 FTE at Meadowlark moving forward. The 1 FTE will be assigned to open a new 3rd grade class. With this addition, the TK-3rd grade average would fall to 26. As of Tuesday we had an increase of 5 additional students at ML impacted our TK-3 numbers. With that said, my team and I are allocated an additional FTE. The additional FTE will be assigned as a 2nd grade teacher. The total number of additional FTEs to ML will be 2. This would keep us to an average of 24, TK through 3rd.

At High Desert, out of the 2 sections of 7th grade, two sections are under by 3 and 1 respectively, while two sections of 8th grade are over by 4 and 2 respectively. With that said, we are looking to add 1 FTE- multiple subject credentialed teacher to the HDS staff.

In total, 3 FTEs will be added to the existing teacher allocation for the district.

Lastly, Ed. Services will be redirecting two TOSAs to lend classroom support for the time being. We will have one TOSA push in her support at HDS for the 5th grade class to support the students and the long-term substitute. A second TOSA will continue to push in their support strategically at all three sites during the AVID electives.

Community Engagement:

➤ The district received a letter dated August 26th from the California High-Speed Rail Authority. The Authority has determined that the District Office, High Desert, and Vasquez are located within one-fourth mile of the proposed project.

There is an online open house and one online public hearing scheduled for October 6th and October 18th, respectively.

In the letter addressed to the district, the authority offers an opportunity for us to meet and further consult with the Authority regarding the potential impact of the project on our schools.

The Authority is providing the option to school districts impacted to meet and further consult with their representatives regarding the potential impact of the HSR project on our schools.

The Authority has provided school districts an opportunity to meet and discuss the proposed project and its impact. I have reached out to the Authority requesting to exercise our right to meet.

I look forward to hearing from them very soon. More to follow on that.

➤ Last Friday, the Salvation Army of Lancaster provided a generous donation of 30 backpacks with school supplies for students in need. We appreciate this partnership which was initiated last fall and look forward to many more years of collaboration. Thank you Ms. Chelcee Humphrey, from the Salvation Army of Lancaster, Mr. Jeff Collins from Pioneers- a volunteer network, and long-time AADUSD supporter and parent, Ms. Tami Crawford. We appreciate the partnership!

Student Safety and Connectedness:

➤ On Tuesday, 8/30, we held our first Student Safety and Wellbeing Meeting, which was open to our community. Meeting was well attended and well represented with student, parents, D.O. staff, as well as school site administration present. Topics included AADUSD's Dept. Of Justice STOP grant scope/overview (with overview provided by grant evaluator), FEMA's Youth Preparedness Council Efforts, Social-Emotional Learning efforts district-wide, and updates by Palmdale Sheriffs and from our own Maintenance and Operations department regarding school site safety measures that were put into place over summer. We are looking to continue our meetings every other month.

Utilization of Fiscal Capital:

On September 1st, LACOE provided us with the Third and Fourth Quarter Williams reports. As cited in Ed Code 1240, a Williams visit to a school district is to determine if students have sufficient standards aligned materials, determine if there is a facility that poses an emergency to health and safety to students or staff, and to determine if the school shave provided accurate data on the SARC reportschool accountability report card. 3rd and 4th quarters reported were between February 2022 through June 2022. I am pleased to report that there we did not have any findings for both quarters.
